

WELS International Youth Rally Terms and Conditions

I understand that the 2009 WELS International Youth Rally for which these Terms and Conditions applies is described as follows:

An international event of the Wisconsin Evangelical Lutheran Synod ("WELS") youth and their adult leaders to be held in Ames, IA on the campus of Iowa State University ("ISU") July 8-11, 2009. This 2009 WELS International Youth Rally includes mass plenary events, smaller group interest workshops/break-out sessions, service projects, fellowship and experiential learning activities.

INSURANCE COVERAGE

I understand that 2009 WELS International Youth Rally participants will be covered by a limited accidental death and accidental bodily injury policy that provides reimbursement up to a minimal dollar amount for medical expenses incurred as a result of purely accidental injuries sustained while at the 2009 WELS International Youth Rally. This coverage is secondary to all other personal/primary insurance coverage available to the participant and will make payment only if such other insurance (participant's primary insurance policy) is not adequate to cover the medical expenses resulting from an accidental injury sustained while at the 2009 WELS International Youth Rally. I understand that I have a duty to provide primary accident and medical insurance for myself and I declare that I am covered by primary accident and medical insurance.

PARTICIPATION CONSENT AND MEDIA RELEASE

I hereby consent to participate in the above-described 2009 WELS International Youth Rally. I have read the informational materials regarding planned activities as supplied by my church's youth leader(s)/pastor(s) and/or on www.welsyouthrally.net. I am aware that in addition to activities such as Bible study, worship, sight-seeing, using public transportation, and meal functions, I also may choose to participate in various recreational/sports activities or service projects that may involve additional risks, such as: jumping, running or other physical movements; or using paint, tools, ladders or other equipment while taking part in service projects.

I give WELS the right to use my image and comments for publicity purposes related directly to the mission of WELS or the 2009 WELS International Youth Rally. I understand that I will not be given any creative control over the use of the images. I further understand that I will not be compensated should the images and/or comments be used. I release and forever discharge WELS and any photographer or production company used by WELS to take or reproduce photographs against all actions and claims.

LIABILITY RELEASE

I RELEASE AND FOREVER DISCHARGE, WELS, ISU, THEIR AGENTS AND SERVANTS, SUCCESSORS AND ASSIGNS, DIRECTORS, TRUSTEES, OFFICERS, EMPLOYEES, AND OTHER REPRESENTATIVES FROM ANY AND ALL LIABILITY, CLAIMS, LOSSES, DAMAGES, COSTS, EXPENSES, AND CAUSES OF ACTION EITHER AT LAW OR IN EQUITY THAT I MAY HAVE AS A RESULT OF MY PARTICIPATION IN, ATTENDANCE AT, AND TRAVEL TO AND FROM THE 2009 WELS INTERNATIONAL YOUTH RALLY. I DO HEREBY EXPRESSLY STIPULATE, AND AGREE TO INDEMNIFY AND HOLD FOREVER HARMLESS WELS, ISU, THEIR AGENTS AND SERVANTS, SUCCESSORS AND ASSIGNS, DIRECTORS, TRUSTEES, OFFICERS, EMPLOYEES, AND OTHER REPRESENTATIVES AGAINST LOSS FROM ANY AND ALL PRESENT OR FUTURE LIABILITY, CLAIMS, LOSSES, DEMANDS OR ACTIONS IN LAW OR IN EQUITY THAT MAY HEREAFTER BE MADE OR BROUGHT BY ME, BY ANYONE ON BEHALF OF ME, OR BY ANYONE ELSE ON THEIR OWN BEHALF FOR DAMAGES OR ANY OTHER LEGAL OR EQUITABLE REMEDY ON ACCOUNT OF ANY INJURY, ILLNESS, PHYSICAL CONDITION, ACCIDENT, INCONVENIENCE, PROPERTY DAMAGE OR LOSS SUSTAINED BY ME DURING THE 2009 WELS INTERNATIONAL YOUTH RALLY OR TRAVEL TO AND FROM THE SAME.
